Liquidators' First Report

1 INTRODUCTION AND APPOINTMENT

Blacktop Construction Limited (In Receivership & In Liquidation) (“the company”) was placed into liquidation by a special resolution of the shareholders pursuant to Section 241(2)(a) of the Companies Act 1993 (“the Act”) on 4 June 2014. Tony Leonard Maginness and Boris van Delden, Insolvency Practitioners of Auckland, were appointed as joint and several liquidators of the company.

2 RESTRICTIONS

This report has been prepared in accordance with Section 255(2)(c) of the Act. In preparing this report and its appendices we have relied upon information provided to us. We have not independently verified or audited that information. Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party as a result of the circulation, publication, reproduction or use of this report.

We reserve the right (but are under no obligation) to review and, if we consider necessary, revise this report in respect of any information existing at the date of this report which becomes known to us after that date.

The company was placed into receivership on 4 September 2013. Andrew Bethell, James Greenway and Brian Mayo-Smith of BDO Auckland were appointed joint and several receivers and managers under the terms of a General Security Agreement ("GSA") dated 19 December 2005 in favour of Westpac New Zealand Limited.

The Receivers determined that the company was not able to be traded on and have been realising the assets.

The two related companies were also placed into receivership on 5th and 6th September 2013 respectively, with the same receivers appointed.

5 STATEMENT OF AFFAIRS

A Statement of Affairs showing the company's estimated financial position has not been prepared. As advised above, the Receivers have been realising the assets of the company. The Receivers' First report recorded assets of \$4,284,000 and liabilities of \$29,000,000. Their second report, for the period from their appointment to 3 March 2014, states that due to the expected shortfall to the secured and preferential creditors there will be no funds available from the receivership for unsecured creditors.

6 ASSETS AND PROPOSALS FOR CONDUCTING THE LIQUIDATION

We will realise any available assets at the completion of the receivership.

We will complete a thorough review of the company's books, records and affairs to:

- ensure that all assets have been properly accounted for,
- determine if there are any other avenues of recovery for creditors,
- determine if the company's officers have properly carried out their duties, and take appropriate steps where necessary.

If there are funds available for distribution to creditors we will verify creditors' claims and make a distribution. We will then complete the liquidation and request that the Registrar of Companies remove the company from the register.

7 LIABILITIES AND CREDITOR CLAIMS

7.1 Secured Creditors

As at the date of liquidation twenty five secured parties had registered security interests against the company on the Personal Property Securities Register. The realisation of assets subject to securities is being managed by the Receivers who distribute proceeds according to the priority created by the securities.

The Receivers' First report recorded a debt of \$12,537,982 plus accrued interest as owing to Westpac New Zealand Limited pursuant to their GSA. Other parties have securities

registered in respect of specific assets or have Purchase Money Security Interests registered in respect of goods provided.

7.2 *Preferential Creditors*

The Receivers' First report stated that preferential creditors including staff and the Inland Revenue Department amounted to \$1,029,602. Their Second report states that there will be a shortfall to the preferential creditors.

7.3 *Unsecured Creditors*

The Receiver's Reports state that there are unsecured trade creditors of \$11.2M. In addition there may be unsecured liabilities by way of shareholders' advances. A schedule of known creditors and their addresses is provided at Appendix 1, as required by Section 255(2)(c) of the Act.

A notice to creditors to prove debts or claims is included at Appendix 2. Also enclosed is a creditor's claim form for completion and return to this office by 18 July 2014. Creditors that have not made a claim by the date on the notice may be excluded from any distribution made. If you believe that you are a secured creditor please contact us and the appropriate form will be sent to you.

8 CREDITORS' MEETING / LIQUIDATION COMMITTEE

A notice of the Liquidators' decision to dispense with the meeting of creditors is provided at Appendix 3.

Pursuant to Section 314 of the Companies Act 1993, creditors are advised that at any time in the course of the liquidation the Liquidator shall, at the request in writing of any creditor or shareholder, call a meeting for the purpose of appointing a liquidation committee.

9 FURTHER INFORMATION

If you are aware of any information that would assist the Liquidators, please set the details out in writing, attach any supporting evidence and send it to us. Please note that the Liquidators are more able to act on written information.
