### 1 INTRODUCTION AND APPOINTMENT

Iain McLennan and Boris van Delden, Insolvency Practitioners of Auckland, were appointed jointly and severally as liquidators of Brusan Designs Limited ("the company") on 10 December 2007.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This twentieth report should be read in conjunction with the liquidators' previous reports. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

### 2 RESTRICTIONS

### 3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

#### *Asset Realisations*

No assets have been identified or realised. The shareholders may have rights to the benefits from litigation in other liquidations.

### 4 INVESTIGATIONS

Given that there are no claims from any party, no investigations are necessary. The circumstances giving rise to the securitisation of assets though may be explored further depending on the outcome of litigation in the liquidation of Neil Timber Limited (in liquidation).

At the time of this report, we have been advised that Mr John Henry Ede has been found guilty of 23 charges under the Insolvency Act, Crimes Act, and Companies Act, and has been sentenced to over 3 years in prison. We will now move on to consider recovery actions.
