Liquidators' Fourth Report To creditors and shareholders for the period from 17 October 2019 to 16 February 2020

1 INTRODUCTION AND APPOINTMENT

Peri Micaela Finnigan and Iain McLennan, Accredited Insolvency Practitioners, of Auckland, were appointed jointly and severally as liquidators of Diana Motors Limited ("the company") on 17 August 2018 by the High Court at Auckland.

Pursuant to Section 255(2)(d) of the Companies Act 1993 ("the Act"), the liquidators herewith report on the progress of the liquidation. This fourth report should be read in conjunction with the liquidators' previous reports. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.

A Statement of Realisations and Distributions is **attached**.

2 RESTRICTIONS

Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party as a result of the circulation, publication, reproduction or use of this report.

We reserve the right (but are under no obligation) to review and, if we consider necessary, revise this report in respect of any information existing at the date of this report which becomes known to us after that date.

3 CONDUCT OF THE LIQUIDATION DURING THE PRECEDING SIX MONTHS

Asset Realisations

3.1 Related Party Claim Settlement

The liquidators recovered \$40,000 from a related party in settlement of a claim against them.

3.2 Third Party Claim Recoveries

We have recovered \$5,000 from a claim against a third party company.

3.3 Interest

Interest of \$50 has been received to date.

4 INVESTIGATIONS

The liquidators have completed their investigations into the books, records and affairs of the company. The liquidators found recoverable transactions to related and third parties which we have recovered.

5 CREDITORS' CLAIMS

5.1 Secured Creditors

No secured claims have been received at the date of this report.

5.2 Preferential Creditor

A preferential claim was received in respect of the applicant creditor's costs of \$4,690 (inclusive of GST). We have paid this portion of the applicant creditor's claim in full.

5.3 Unsecured Creditors

As at the date of preparing this report two unsecured creditors claim forms have been received which total \$30,754. The unsecured creditors have received \$26,3500 towards their claims.

6 LIQUIDATORS' FEES

Liquidators' fees to the date of this report are \$13,924 excluding GST. The fees are based on 81 hours of work undertaken as follows:

Liquidators' fees in a Court ordered liquidation are to be approved by the Court and if required a retrospective application for fee approval will be made by the liquidators.

Section 284 (1) of the Act provides that an application (with the leave of the Court) may be made by a creditor, shareholder or director of a company in liquidation to review or fix the remuneration of the liquidators. In circumstances where no application has been made to review or fix the liquidators' remuneration the Court will be less inclined to rigorously examine the fees submitted by the liquidators for subsequent approval.

7 FUNDS / LIKELY OUTCOME

There are no further distributions to unsecured creditors.

8 MATTERS DELAYING THE COMPLETION OF THE LIQUIDATION

There are no further matters delaying completion of the liquidation.

9 ESTIMATED DATE OF COMPLETION

We will now seek approval of fees and proceed to close the liquidation.
