1 INTRODUCTION AND APPOINTMENT

Supreme Meats & Smallgoods Limited (in receivership) ("the company") was placed into liquidation by the High Court at Auckland pursuant to Section 241(2)(c) of the Companies Act 1993 ("the Act") on 20 July 2018 at 10:07 am on the application of the petitioning creditor, Brocklyn Trading Limited. Peri Micaela Finnigan and Iain McLennan, Accredited Insolvency Practitioners, of Auckland, were appointed joint and several liquidators of the company.

2 RESTRICTIONS

In preparing this report and its appendices, we have relied on information provided to us. We have not independently verified or audited that information. Whilst all care and attention has been taken in compiling this report, we do not accept any liability whatsoever to any party arising from the circulation, publication, reproduction, or use of this report.

3 INDEPENDENCE

5.2 Background

Bank of New Zealand appointed Andrew John Grenfell and Conor John McElhinney, of McGrathNicol Limited, as joint and several receivers and managers of the company on 23 March 2018. Subsequent to the appointment of receivers, the petitioning creditor filed an application in the High Court at Auckland seeking to put the company into liquidation. That application was granted on 20 July 2018. At the time of our appointment, the receivers were in control of the company.

The liquidators have been advised by the receivers that:

In November 2017 the directors commenced a process to raise additional capital and/or sell part or all of the Company. The process was unable to be successfully concluded and the directors requested the Secured Lender appoint receivers over the Company...An unconditional offer for the business and assets of the Company (excluding debtors) was accepted by the Receivers and the sale settled on 3 April 2018, for \$820,000. The purchaser, Deli Meats NZ Limited, took an assignment of the Company's lease and offered employment to majority of the staff.

6 STATEMENT OF AFFAIRS

A Statement of Affairs showing the company's estimated financial position as at the date of our appointment is provided at Appendix 1.

7 ASSETS AND PROPOSALS FOR CONDUCTING THE LIQUIDATION

The receivers have advised that they:

- have sold the company's assets

- are collecting the company's outstanding accounts receivables
- have paid employees' preferential claims in full
- are assessing PMSI creditors' claims and making distributions as appropriate
- consider that there are unlikely to be any funds available for unsecured creditors
- anticipate retiring before the liquidators' next six-monthly report is filed

We will complete a thorough review of the company's books, records and affairs to:

- ensure that all assets have been properly accounted for
- determine whether there are any other avenues of recovery for creditors
- determine whether the company's officers have properly carried out their duties

Following our investigations, we may take recovery or enforcement actions for the benefit of creditors, which the liquidators will assess on a cost/benefit basis.

If there are funds available for distribution to creditors, we will verify creditors' claims and make a distribution. We will then complete the liquidation and request that the Registrar of Companies remove the company from the register.

8 LIABILITIES AND CREDITOR CLAIMS

A schedule of known creditors, taken from the company's books and records, and their addresses is provided at Appendix 3, as required by Section 255(2)(c) of the Act. Every party in

Creditors wishing to lodge a claim in the company's liquidation should complete the appropriate creditor's claim form then submit the completed claim and supporting documents to our offices by Friday, 31 August 2018. Creditors that have not made a claim 31 August 2018 may be excluded from any distribution made by the liquidators.

8.3 Preferential Creditors

The applicant creditor was awarded costs and disbursements on the liquidation application totalling \$4,239.64. The liquidators have not made any distributions in respect of this preferential claim.

The receivers have advised that:

- all preferential employee claims have been paid in full from recoveries made by the receivers
- they estimate that the Commissioner of Inland Revenue's preferential claim for outstanding GST and PAYE is \$87,000
- they anticipate that the Commissioner's preferential claim will be paid in full from realisations made by the receivers

8.3 Unsecured Creditors

Based on the company's accounting records received and other information provided, we estimate that the amount owing to unsecured creditors is approximately \$1.65 million.

9 CREDITORS' MEETING / LIQUIDATION COMMITTEE

A notice of the Liquidators' decision to dispense with the meeting of creditors is provided at Appendix 4.

Any creditor or shareholder may, at any time in the course of the liquidation, request that the liquidators call a meeting pursuant to Section 314 of the Companies Act 1993 for the purpose of appointing a liquidation committee. Any request for a meeting must be submitted to the liquidators in writing.

10 FURTHER INFORMATION

If you are aware of any information pertaining to the company or its directors that may assist the liquidators, please set the details out in writing, attach any supporting evidence, and send it to us. Please note that it can be difficult for liquidators to act in reliance on information that is not provided in writing.

If you are an unsecured creditor and you do not lodge a claim, you will not be sent a copy of the liquidators' six-monthly reports.





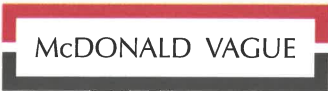
