#### **1 INTRODUCTION AND APPOINTMENT**

John Trevor Whittfield and Peri Micaela Finnigan, Insolvency Practitioners of Auckland, were appointed jointly and severally as liquidators of Titan1 Finance Limited (“the company”) on 20 August 2009 by the High Court at Palmerston North. John Trevor Whittfield resigned his position as liquidator on 27 August 2010 on the appointment of Boris van Delden as his successor. Peri Micaela Finnigan resigned his position as liquidator on 25 June 2022 on the appointment of Iain McLennan as his successor.

Pursuant to Section 255(2)(d) of the Companies Act 1993 (“the Act”), the liquidators herewith report on the progress of the liquidation. This report should be read in conjunction with the liquidators’ previous reports. This report is being sent to all shareholders and all creditors who have filed a claim in the liquidation.
